'John Maund' (1772 - 1850) and 'Capel Hanbury Leigh' (1776 - 1861)

#### **INSCRIPTION and NOTES**

At the 'Northern' end of the 'Twmbarlwm' hill range starting from 'Upper Race' near to the town of 'Pontypool', whilst following the forest boundary line in a 'Westerly' direction towards 'Twyn Calch' and 'Mynydd Llwyd', many similarly inscribed boundary stones can be found.

On one side of the boundary stone are the inscribed initials 'CHL' for 'Capel Hanbury Leigh' of 'Pontypool Park' **PLUS** 'Roman numerals' and on the opposite side are the inscribed initials 'IM'.

With a limited amount of undertaken research, 'IM' could for stand for 'Iron Master', 'John Morgan of the 'Tredegar Estate' or 'John Maund' of 'Panteg', Monmouthshire, Wales.

Knowing the fact that the 'English' alphabet contains 26 letters, as opposed to that of the 'Roman' alphabet which only contains 23 letters (those missing letters being J, U, and W), it is believed that the 'I' in 'IM' is in fact a 'J' and therefore relates more to that of 'John Maund' of 'Panteg'. In addition, due to where the boundary stones are located, this increases the likelihood that the 'IM' does lean more towards that of 'John Maund' of 'Panteg'; but this is not conclusive.

Knowing the above information, I have undertaken further research in regard to the family 'Maund' with particular reference to that of 'John Maund (I)' (1772 - 1850) as he ties in with 'Capel Hanbury Leigh (1776 - 1861).

# **JOHN MAUND (I) 1772-1850**

### **Andrew Maund (1722-1803)**

Andrew Mound (1722-1803) was born in 1722.

On 20th March 1759, Andrew Mound (1722-1803 (Aged 37) married Elizabeth Price (1734-1796) (Aged 25) in the Parish Church, St John The Evangelist, Breconshire, Wales. They had seven (7) children: James, Elizabeth, Andrew, Hester, Howell, Anne, **JOHN** Maund (I) (1772-1850) and James.

In 1803, Andrew Mound (1722-1803)) died aged 81 in Brecon, Breconshire, Wales; he was a 'Builder'.

### John Maund (I) (1772-1850)

John Maund (I) (1772-1850) was born in 1772 to parents Andrew Mound (1722-1803) and Elizabeth Price (1734-1796).

Although as yet no marriage certificate has been found, it is believed that John Maund (I) (1772-1850) married Mary Monkhouse (1792-1857) prior to the birth of their two sons; John Atkinson Maund (1831-1831) and <u>JOHN</u> Maund (II) (1835-1876).

In 1841, John Maund (I) (1772-1850) (Aged 69) was living in Blaendare, Panteague, Pontypool, Monmouthshire with his wife Mary Monkhouse (1792-1857) (Aged 47) and Sister-in-law Frances Isaacson.

In 1850, John Maund (I) (1772-1850) died aged 79 at 'Tymawr', Llanelly Parish, Brecknock; the burial was carried out on 8<sup>th</sup> November 1850 at St John The Evangelist, Breconshire, Wales. John Maund (I) (1772-1850) was an architect.

### JOHN MAUND (I) (1772-1850) is the - **FATHER** – to JOHN MAUND (II) (1835-1876)

### John Maund (II) (1835-1876)

John Maund (II) (1835-1876) was born on 1835 to parents John Maund (II) (1772-1850) and Mary Monkhouse (1792-1857) and was baptised on 29<sup>th</sup> April 1835 in the Parish of Panteague, Monmouth, England. At the time the family were living at 'Maesyderwen'.

In 1841, John Maund (II) (1835-1876) (Aged 6) was living with relatives in 'Hill Street', St John The Evangelist, Breconshire, Wales.

In 1851, John Maund (II) (1835-1876) (Aged 15) was a 'Scholar' living at a 'Church School' in 'Sherborne, Dorset'.

On 24th April 1860, John Maund (II) (1835-1876) (Aged 25) who was deemed to be a 'Gentleman' married Louise Clifford Hansby (1841-1891) (Aged 19) in the Parish Church, Llanelly, Brecon. During their life together they had five (5) children: Mary, Louisa, John, Elizabeth & William.

In 1861, John Maund (II) (1835-1876) (Aged 25) was the 'Head' of the household and living with wife Louise (Aged 20) and Daughter Mary (1 Mth). The family were living at 'Duffryn Mawr', Llanelly, Aberbaidon, Breconshire, Wales. John was a practicing 'Justice of the Peace' and also 'Deputy Lieutenant' he also employed nine (9) men and five (5) boys.

On the day of the 1871 Census, John Maund (II) (1835-1876) (Aged 36) continued to be the 'Head' of the household, however he was only living with his children John (7), Elizabeth (6) and William (5) at '3 Crescent Road', South Norwood Park, Croydon, Surrey, England. John was still a 'Justice of the Peace' but he was now a 'Wine Merchant'.

Between 1871 and 1876, John Maund (II) (1835-1876) and his family moved to France.

On the 6<sup>th</sup> May 1876 John Maund (II) (1835-1876) died aged 41 at '16 Rue de Calais', Boulogne-sur-Mer, France. However his 'Will' was 'Proved' in London and his wealth was left to his wife Louise Clifford Hansby (1841-1891).

Grant of Probate states – The Will of John Maund, formerly of 3 Crescent Road, South Norwood Park in the County of Surry but late of 16 Rue de Calais', Boulogne-sur-Mer, France Esquire who died 6 May 1876 at 16 Rue de Calais' was proved at the Principal Registry by Louisa Clifford Maund, of 16 Rue de Calais' Widow of the relict one of the Executors.
